

## **Consideration of the Proposed 2011 Board of Nursing Rule Review Schedule**

**Summary of Request:** Consider approval of the Board's 2011 Rule Review Plan.

**Background:** The Government Code §2001.039 (Administrative Procedure Act) requires a state agency to review each of its rules every four years following the rule's initial effective date to determine if the reasons for originally adopting the rule continue to exist. The agency must then consider whether to re-adopt, re-adopt with amendments, or repeal each rule. The Board completed the implementation of its 2007 rule review plan on September 18, 2009. Attached hereto as Attachment "A" is Staff's proposed 2011 rule review plan. This rule review plan continues the timeline established by the Board's previous rule review plans.

**Staff Recommendation:** Move to approve the Board's 2011 Rule Review Plan as set out in Attachment "A", with authority for General Counsel to make editorial changes as necessary to clarify Board intent and to comply with the formatting requirements of the *Texas Register*. Further, move to authorize Staff to file the Board's 2011 Rule Review Plan with the Secretary of State's Office and to publish the Board's 2011 Rule Review Plan in the *Texas Register*.

Chapter 224. Delegation of Nursing Tasks by Registered Professional Nurses to Unlicensed Personnel for Clients with Acute Conditions or in Acute Care Environments. (October 2011)

As a result of its review, the Texas Board of Nursing will re-adopt, re-adopt with amendments, or repeal rules following its assessment of whether the reasons for initially adopting the rules continue to exist.
