## Texas RNs Asked to Complete Online Professional Practice Accountability Survey

All registered nurses (RNs) in Texas are requested to complete the 2011 *Professional Practice Accountability: Law and Regulation* online survey. The purposes of the survey are to: (1) obtain demographic information, and (2) determine RNs' understanding of the laws and regulations affecting nursing practice in Texas.

The survey is being conducted by Dorothy Otto, RN, EdD, ANEF, and Edith Summerlin, RN, PhD, both faculty of The University of Texas Health Science Center - Houston School of Nursing, along with Katherine Thomas, RN, MN, Executive Director of the Texas Board of Nursing.

The survey takes approximately 15 minutes to complete and closes on September 15, 2011. The results of the survey will be published in the Spring 2012 *Texas Board of Nursing Bulletin*. A similar study of RNs was conducted in 1998. The Board anticipates asking vocational nurses to complete a similar survey in the future.

## 82<sup>nd</sup> Texas Legislature Adjourned; BON Examines Passed Legislation

The 82<sup>nd</sup> Regular Texas Legislative Session ended on May 31, 2011, followed immediately by a Special Session which adjourned on June 28, 2011. The Texas Board of Nursing (BON) is currently reviewing bills which impacted the Nursing Practice Act, Board Rules and Regulations, and agency operations. Several bills of significance which were passed into law include:

- \* House Bill (HB) 2975 and Senate Bill (SB) 1360 which add continuing education recommendations for nurses treating patients with tick-borne diseases;
- \* SB 192 adds additional penalties against those individuals attempting to impede nurses from advocating on behalf of their patients;
- \* SB 193 allows nurses under 65 years old to apply for retired status and use the appropriate title signifying this status; authorizes the disclosure of the results of a physical or psychological exam to the Board to determine fitness to practice nursing; and allows the BON to develop a standardized error classification system for use by a nursing peer review committee; and
- \* SB 1857 calls for the development and oversight of a pilot program to evaluate LVNs providing on-call services to clients by telephone to be conducted by the BON in conjunction with the Department of Aging and Disability Services.

The BON will provide an in-depth review of all nursing legislation passed during the 82<sup>nd</sup> Session in the October edition of the *Bulletin*.

## Summary of Actions

A regular meeting of the Board of Nursing was held April 28-29, 2011, in Austin. The following is a summary of Board actions taken during this meeting.



Proposed new 22 Tex. Admin. Code §217.21, pertaining to *Remedial Education Course Providers and Remedial Education Courses*, and proposed amendments to §223.1, pertaining to *Fees*, were approved by the Board at its April 28-29, 2011 meeting for submission to the *Texas Register* for public comment and for adoption if no negative comments or a request for a public hearing were received. The proposed new section and amendments were published in the *Texas Register* on May 27, 2011, and the comment period ended on June 27, 2011. Written comments were received. A public rule hearing was held on June 29, 2011. The written and oral comments will be considered by the Board at its July, 2011 meeting.

The proposed amendments to 22 Tex. Admin. Code §221.6, pertaining to *Interim Approval*, were approved by the Board at its April 28-29, 2011 meeting for submission to the *Texas Register* for public comment and for

adoption if no negative comments or a request for a public hearing were received. The proposed amendments were published in the *Texas Register* on June 3, 2011 and the comment period ended on July 5, 2011. The Board did not receive any comments on the proposal or a request for a public hearing. The adoption of the proposed amendments will be published in the *Texas Register* on July 22, 2011 and will become effective on July 26, 2011.

The proposed amendments to 22 Tex. Admin. Code §217.5, pertaining to *Temporary License and Endorsement*, were approved by the Board at its April 28-29, 2011 meeting for submission to the *Texas Register* for public comment and for adoption if no negative comments or a request for a public hearing were received. The proposed amendments were published in the *Texas Register* on June 3, 2011, and the comment period ended on July 5, 2011. The Board did not receive any comments on the proposal or a request

for a public hearing. The adoption of the proposed amendments will be published in the *Texas Register* on July 22, 2011 and will become effective on July 26, 2011.

In the June 24, 2011 issue of the *Texas Register*, the Texas Board of Nursing filed notice of intention to review and consider for re-adoption, re-adoption with amendments, or repeal, the following chapters of the Texas Administrative Code: Chapter 211, *General Provisions*; Chapter 217, *Licensure, Peer Assistance and Practice*; Chapter 219, *Advanced Practice Nurse Education*; and Chapter 223, *Fees*. ## When the Profession is Nursing and the Title is Doctor . . .

One of the hallmarks of nursing is the approach to lifelong learning. As nurses earn advanced degrees, the number of nurses earning doctoral degrees is increasing. The longstanding tradition of addressing a person with an earned doctoral degree as “doctor” began many centuries ago as did the tradition of addressing a physician as “doctor”. The number of healthcare professionals with earned doctoral degrees may contribute to confusion for the public and for members of the healthcare team.

### *Credentials by Law*

Known as the Healing Art Identification Act, Texas Occupations Code, Chapter 104 addresses the use of the term doctor.<sup>1</sup> To comply with the law, a nurse is required to include the degree that allows use of doctor as a credential<sup>2</sup> and indicate the profession being practiced. The Nursing Practice Act and Board Rules mandate that a Licensed Vocational Nurse (LVN) and a Registered Nurse (RN) display a clearly legible insignia specifying name and licensure level.<sup>3</sup> The Advanced Practice Registered Nurse (APRN) is identified both as a RN and uses the appropriate advanced practice title authorized by the Board of Nursing (BON) when providing advanced practice care to patients.<sup>4</sup>

Based on requirements in the Texas laws, doctorally prepared nurses could not simply identify themselves as *Dr. \_\_\_\_\_*. The nurse must include the academic credential such as PhD (Doctor of Philosophy), DNS (Doctor of Nursing Science), DNP (Doctor of Nursing Practice), or any other doctoral degree. Nurses must also include licensure level with appropriate APRN title, if applicable.

### *Communication*

Communication takes many forms. Some verbal communications occur in person and have associated visual cues such as a name badge. Other verbal communications may occur by telephone, presenting unique challenges in assuring the parties are correctly identified. The information exchange should include the name and licensure level of the parties involved. Written communications are required to include the name, licensure level, and the appropriate advanced practice title, if applicable, and may include academic degrees and certifications. The academic credential cannot replace the licensure credential.

Inadequate identification of a nurse can be confusing to the public. Failure to comply with laws, rules, and regulations

can result in disciplinary action. When using a doctoral credential, nurses are obligated to use the term in compliance with the law by identifying the “degree that gives rise to the use of the title”.<sup>2</sup>

## Advisory Committee Update

### **Deferred Disciplinary Action Pilot Program Advisory Committee**

The first meeting of the Committee was held on June 29, 2011. The Committee discussed its role in assisting the Board in evaluating and overseeing the deferred disciplinary action pilot program. Poldi Tscirch, PhD, RN, BC, was elected Chair. Dr. Tscirch served previously as Chair of the Board of Nursing Eligibility and Disciplinary Task Force. The Committee anticipates a second meeting in the next few months.

### **Nursing Practice Advisory Committee**

The Nursing Practice Advisory Committee (NPAC) met on June 8, 2011 in Austin. Laura Miller, MSN, RN, elected as Chairperson for NPAC, served as the facilitator for the meeting. Committee members drafted scope of practice position statements for LVNs and RNs designed to benefit nurses and employers. The NPAC committee members’ recommendations will be submitted for the Board’s consideration at the July 2011 Board meeting.

### **Question:**

What should a nurse do to help in the event of a disaster?

### **Answer:**

*Ready Texas Nurses* is a web-based, emergency response system designed to activate volunteer nurses in times of crisis and disaster. Both RNs and LVNs can register to volunteer. ## Nurses On Guard – Best Practice in Patient Safety Delegation versus Assignment

The use of terms *delegate* and *assign* can be confusing and lead to questions regarding the licensure responsibilities associated with the terms.

Delegation is defined as “*authorizing an unlicensed person to provide nursing services while retaining accountability for how the unlicensed person performs the task. It does not include situations in which an unlicensed person is directly assisting a RN by carrying out nursing tasks in the presence of a RN.*”<sup>1</sup> While registered nurses (RNs) or advanced practice registered nurses (APRNs) are responsible for delegating the right task to the right person in the right set of conditions, the education, knowledge, experience, competency, and supervision of the unlicensed person is at the forefront.

Assignment means designating responsibility for a specific activity or set of activities to either another licensed nurse or to unlicensed assistive personnel

(UAP).<sup>2</sup> Patient safety and the abilities of the person to whom the assignment is being made are important criteria to consider when making an assignment. The assignments that may be made are influenced and guided by the education, knowledge, experience, and physical and emotional abilities of the person to whom assignments are made.<sup>3</sup> Patient safety can be impacted by the complexity or acuity of the patient’s health status and the physical environment in which care is provided.

LVNs have a supervised practice under the oversight of a RN, APRN, physician, dentist or podiatrist.<sup>4</sup> While LVNs can assist in the nursing process by assigning certain tasks to UAPs, the RN is responsible and accountable for supervising not only the LVN’s practice but the UAP’s performance of tasks as well. A nurse has a licensure obligation when accepting an assignment and is responsible for both the acceptance of

the assignment and carrying out the assignment.

A RN may train, verify competency, and delegate tasks to a UAP; the LVN may then proceed to assign those tasks that need to be accomplished for that day. This may seem like a minor detail; however, it is a good example of how the RN, LVN and UAP work together to deliver safe care while the RN retains the overall responsibility for the coordination of care.

The Texas Board of Nursing recognizes that changes in health care delivery have and will continue to influence the way nursing care is delivered. The utilization of appropriate delegation or appropriate assignment by the RN benefits clients and ensures their safety.
